WARRANTY -PRO-RATED

THIS IS A LEGAL CONTRACT BETWEEN YOU AND  
SEATS INCORPORATED

Seats Incorporated expressly warrants that all mechanical seat components in its i3MM and Mariner SEATING shall be free from defects in material and workmanship when delivered to the original purchaser for 12 months from the date of sale provided such seats are subject to normal use and receive proper maintenance. Seats Incorporated expressly warrants that the cushions and seat covers shall be free from defectively sewn seams for a period of 6-months, excluding normal wear and tear. Corrosion related claims are not covered by this warranty.

Your sole and exclusive remedy against Seats Incorporated arising from the purchase or use of i3MM and Mariner SEATING is limited to repair or replacement of defective materials or defective workmanship after verification by Seats Incorporated.

All warranty claims shall have prior approval from Seats Incorporated's warranty department, 1-800-443-0615 (outside Wisconsin), 1-608-524-4316 (inside Wisconsin). All seats will be repaired or replaced at the sole discretion of Seats Incorporated.

These warranties will become null and void if:

- The seat is abused or altered
- The seat is involved in an accident
- The seat is improperly installed
- The seat is used for other than its intended use
- There is damage to the cushions and covers caused by cuts, burns or abuse.

WARRANTY DISCLAIMERS AND LIMITATIONS OF LIABILITY

THE ABOVE EXPRESSED WARRANTIES SHALL BE THE EXCLUSIVE WARRANTIES, AND SEATS INCORPORATED MAKES NO OTHER WARRANTIES, EXPRESSED OR IMPLIED. SEATS INCORPORATED EXPRESSLY DISCLAIMS ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE

IT IS AGREED THAT SEATS INCORPORATED SHALL NOT BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, including but not limited to, loss of income, loss of use, lost profits, damage to other property, the cost of removing and reinstalling the RAILROAD SEATING, attorney's fees, and any liability you may have with respect to any other person.

TIME LIMIT COMMENCING LEGAL ACTION

It is agreed that you have one year from the accrual of a claim to commence any legal action arising from the purchase or use of the Marine SEATING, or be barred forever.
